 - Specific outcomes from the Montgomery County Community Food Security Advisory Board:
 - CAB members have provided feedback to food assistance providers about programs that has resulted in changes being made to ensure better food access, have (i) attended the National Anti-Hunger Policy Conference and shared their stories of food insecurity with congressional representatives on Capitol Hill; (ii) written and presented oral testimony in Annapolis on a bill to increase SNAP access for those affected by the public charge rule, (iii) written to and met with Montgomery County Councilmembers in order to highlight the need for more prepared food options for food insecure residents with mental and physical disabilities, iv) worked with local nonprofit Maryland Hunger Solutions to schedule online SNAP appointments and provide food assistance resources to food insecure Marylander, (v) been interviewed by local and national media outlets to share their experiences of food insecurity and the work that they have been doing with the CAB, and (vi) worked with a research organization to provide testimony about their experiences to inform a peer reviewed study about food access in America.
